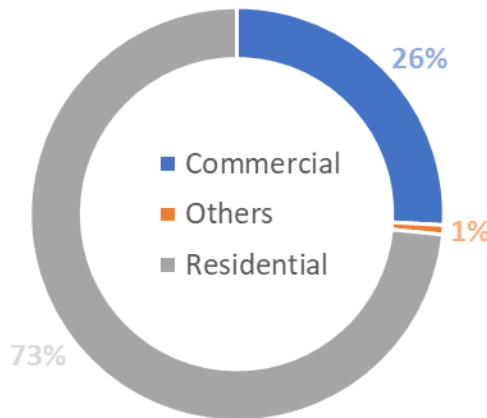
September 2018 Project valuation



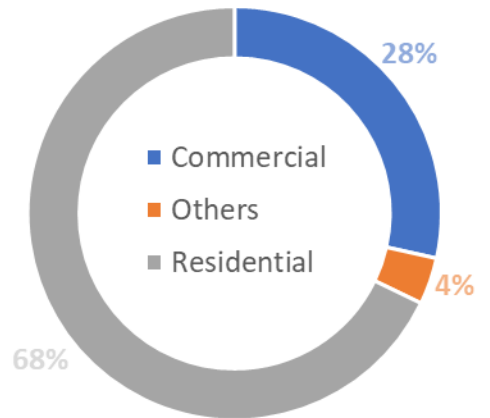
